 HMIS Program: The Homeless Management Information System provides a shared electronic case management system including software, hardware, internet service as appropriate, and all training to various homeless service providers in the effort to end homelessness. HMIS is mandated by the US Department of Housing and Urban Development in an attempt to quantify homelessness, to track services provided by community agencies, and report progress towards ending homelessness. One Roof is the HMIS Lead entity for central Alabama and manages the Program Information System of the Southeast (PromisSE), a shared HMIS platform utilized by HUD Continuums of Care and homeless service providers across the State of Alabama and the Florida Panhandle. A total of 70 agencies participate in PromiseSE with more than 450 end users in the system.

4b (Code:) (Expenses \$ **595,508** including grants of \$ **584,030**) (Revenue \$ **0**)
 Coordinated Assessment/Entry: One Roof operates and oversees the Coordinated Entry program for Central Alabama. Coordinated Entry is a HUD mandated program designed to provide easy access to homeless services, quickly assess the vulnerabilities of persons seeking assistance, prioritize persons with the highest needs and vulnerabilities, and appropriately refer individuals and families to service providers within the community. Serving as a clearinghouse for homeless services, Coordinated Entry helps ensure persons with the highest needs and vulnerabilities to continued homelessness are prioritized for assistance. As part of the Coordinated Entry program, One Roof partners with the YWCA of Central Alabama and the State of Alabama in the AmeriCorps program, a national service initiative placing AmeriCorps service members with nonprofit agencies to help expand their capacity. One Roof currently has 4 AmeriCorps service members who assist with the Coordinated Entry program. Coordinated Entry is also the home for a dedicated 4-person Street outreach Team and Alabama's only dedicated SSI/SSDI, Outreach, Access, Recovery (SOAR) social worker. Street Outreach team members provide essential emergency services and case management to people who are unsheltered, and the SOAR social worker assists persons who have a disability and are experiencing homelessness, in attaining Social Security benefits.

4c (Code:) (Expenses \$ **304,261** including grants of \$ **264,688**) (Revenue \$ **0**)
 Continuum Planning: In partnership with homeless service providers, local municipal governments, education leaders, state officials, the faith community, and other dedicated organizations, the One Roof Continuum Planning program seeks to plan and respond to HUD Continuum of Care requirements to identify, divert, serve, and permanently house people who are experiencing homelessness in Central Alabama. The ultimate goal is to maintain a crisis response system that makes homelessness rare, brief, and nonrecurring. One Roof is the designated lead entity in this planning process and seeks to coordinate efforts to end homelessness across all community partners, including local Emergency Solutions Grant (ESG) entitlement areas and agencies funded through the Continuum of Care program. One Roof is responsible for evaluating ESG-funded and Continuum-funded programs that serve and house people experiencing homelessness in and effort to ensure federal resources are spent effectively. As part of this evaluation, One Roof reports performance data to ESG entitlement area, state officials, and HUD. One Roof also submits and annual competitive grant to HUD on behalf of homeless service providers totaling \$10.1 million.

 In response to the COVID-19 pandemic during 2020, One Roof operated a temporary shelter from May 2020 to December 2020 for homeless individuals to ensure adequate quarantine space for individuals entering existing congregate shelters. In addition, One Roof provided hotel vouchers to homeless individuals with COVID-19 until they could safely enter local congregate shelters.

 In addition to the COVID-19 temporary quarantine shelter and hotel vouchers described in Part III, Line 2 (with expenses of \$115,342 including grants of \$99,980 and revenue of 0), One Roof also staffs the local warming station when opened by the City in extreme temperatures. One Roof additionally provides local service programs such as Project Homeless Connect and educational programs such as Cardboard Connect.
