- Project Homeless Connect Recap & Thank You One Roof
 - This year One Roof sent out their outreach team in addition to Alethia House to pick up clients.
 - This year One Roof had staff members at legal and state ids to ensure clients receiving this assistant is literally homeless.
 - Thoughts about stopping any clients who are not homeless at the door.
 - Membership mentioned the idea of two different wrist band. One for housed and one for unhoused.
 - Val Green suggesting training the smiling faces to access for literally homeless clients.
 - April McMaster suggested having a table with information at the front before entering the room
 - Val Green stated there was not enough cameras for continuum ids.
 - Michelle suggested doing a combination of weeding out in the front and giving out different color ids.
 - o 55% were literally homeless-emergency shelter or on the streets.
 - o 92 veterans were at PHC. The veteran services did a great job getting their clients to the event.
 - Approximately 7 new service providers were at PHC.
 - The youth section needs more space. The word needs to get out to youth and get them to the event.
 - There will never be clothing at PHC because of space and there are plenty of clothes closets in the community.
 - The IRS Tax Payers was there with any new tax questions.
 - PS Serving Veterans and the Community had vouchers for seniors to the farmer's market.
 - Urban Ministries-68 people were registered who were literally homeless. They were able to transport several clients directly to shelter. 12 people called on Monday for homelessness prevention through PHC.
 - ARMS also volunteered to take over coordinating the medical section for next year's PHC.
