II. Special Presentations: Serving our Veterans

- Volunteers Of America (VOA) of the Southeast, Katrese Barker, SSVF Program Manager
 - Must be literally homeless to receive SSVF Rapid Rehousing
 - o Must be imminently at-risk of homelessness to receive SSVF Homeless Prevention
 - Housing First philosophy: house Veterans quickly and then provide wraparound services and supports.
 - o Participants must be a Veteran; if a family, the Veteran must be in the household.
 - o Income cannot exceed 50% of Area Median Income (AMI)
 - o Discharge status cannot be dishonorable.
 - It's ok if the Veteran does not have their DD214; SSVF provider will help Veteran get this document.
- Priority Veteran, Lula Skowronek, Director (SSVF provider)
 - o Eligibility and program rules are the same as VOA Southeast's program.
 - During COVID, SSVF requirements became more flexible and there were fewer limits on length of assistance. These flexibilities will likely end soon.

III. Continuum Business

- The Special Unsheltered NOFO (Notice of Funding Availability) application was submitted on October 20, 2022.
 - One the One Roof website, click on the <u>CoC Funding Opportunity</u> to view the entire application, especially the letter submitted by the Person with Lived Experience (PLE) committee.
 - Moving forward, any CoC committee or workgroup meetings will include at least 1PLE, and preferably 2 or more PLEs involved in the activities of these groups. PLEs must have recent experience of unsheltered homelessness.
 - Some additional work is necessary for the rating and ranking process for the annual NOFO process.
 - Need to consider move-on strategies and not to keep program participants in CoC-funded housing indefinitely.
 - Need to consider the cost-to-outcome ratio.
 - Anne Ryigel, Dena Dickerson, Sherry Bray, Amanda Byrd (UAB Psych), and Michele Figueroa-Ham are interested in serving on this Rating and Ranking Workgroup.

 - Total Number of Individuals/Households on the CE referral list as of 11/2/22 = 306
 - Total Number of Completed CAs in September 2022 and October 2022
 - September 1st September 30th, 2022 = 74
 - October 1st October 31st, 2022 = 34
 - o Total Number of Referrals Requested in September 2022 and October 2022
 - September 1st September 30th, 2022 = 33 (15 PSH, 15 RRH, 3 TH-RRH)
 - October 1st October 31st, 2022 = 41 (16 PSH, 20 RRH, 5 TH-RRH)
