HMIS PROGRAM: Provides a computerized tracking system, including software, hardware, internet service, and computer training to various agencies in the fight against homelessness. This is a HUD mandated system in an attempt to understand, qualify, and end homelessness. To date, 41,635 individuals have been entered into HMIS. A total of 58 agencies participate in this effort, with 140 end users. There have been 1,398,710 total services recorded.

SOAR Program. This program, Social Security Outreach, Access Recovery, provides a specially trained social worker to outreach to disable persons living on he streets and other places unfit for human habitation and assist them to successfully apply for federal benefits. Theses individuals are eligible for reduced rate housing and eventually qualify for medical benefits. TShe program successfully assisted 20 of the 20 persons who applied to receive SSI or SSDI benefits.
